LeanControl is an all-natural formula that also contains specific vitamins involved in nutrient and cellular metabolism.

Each capsule contains:

L-Phenylalanine: Is the natural form of an essential amino acid that can inhibit appetite by stimulating the production of the appetite-suppressing hormone cholecystokinin, creating a physiological feeling of fullness. L-Phenylalanine can play a role in fat loss by serving as a precursor to hormones and neurotransmitters involved in energy production, metabolism, breakdown of triglycerides and mobilization of fatty acids.

Vitamin C and B6: Are required for the conversion of phenylalanine to norepinephrine by the brain. Norepinephrine plays a primary role in the breakdown and use of fat for fuel. Vitamin C and B6 also help to maintain the protein collagen and give strength to blood vessels.

Vitamin B6 Pyridoxine: Is a natural diuretic and mood stabilizer that also helps to metabolize fats and carbohydrates and to maintain the balance of sodium and potassium that regulates body fluids. the balance of sodium and potassium, which regulates body fluids.

Vitamin B5 Pantothenic Acid: Is an essential part of coenzyme A, which plays an important role in the breakdown of fats and carbohydrates for energy. It can also improve the body's ability to withstand stressful conditions and may aid in the prevention of premature aging, wrinkles and borderline hypoglycemia.*
